The deaths registered in the past week in the several towns, alphabetically arranged, corresponded to the following annual rates per 1,000:-Armagh, 207; Belfast, 154; Cork, 344; Drogheda, 42; Dublin, 481; Dundalk, 44; Galway, 336 Kilkenny, 169; Limerick, 202; Lisburn, 242 Londonderry, 481; Lurgan, 103; Newry, 176 Sligo, 28.9; Waterford, 6.9; Wexford, 4.3. The deaths from the principal zymotic diseases in the 16 districts were equal to an annual rate of 5.2 per 1,000, the rates varying from 0.0 in nine of the districts to 12.5 in Lendonderry; the 27 deaths from all causes registered in that district comprising 6 from whooping cough and 1 from diarrhœa.

This he said was called a Wharncliffe meeting of the company, and it was absolutely necessary in order that their proceedings could come before Parliament that they should be approved of by a majority of three-fourths of the shareholders voting and present.
