

Mr Conway, and seconded by Mr. McHenry, concluded the proceedings.

MR PARNELL AT BALLINA.

Mr Parnell, speaking at Ballina yesterday, justified his support of the Land Purchase Bill on the grounds that all beneficial measures from England should be accepted by the Irish people without prejudice to their demand for Home Rule, and that Mr Balfour is quite as well entitled to reduce Irish rents as Mr Gladstone was in 1881. He added that if Mr Balfour's Bill will reduce the rents by 40 per cent in two or three years, whereas Mr Gladstone took seven years to reduce them by 17 per cent, he is doing better than Mr Gladstone, who, from 1881 to 1885, was coercing the Irish people quite as badly as Mr Balfour without spending a shilling of British money on the country.

APPOINTMENTS AT THE LAW COURTS.

The *Dublin Evening Mail* understands that Mr Henry M Pilkington, Q.C., LL.D., has retired from his position as Chief Registrar of the Probate and Matrimonial Division. Mr Pilkington earned a high reputation as a lawyer in church and probate law; and upon the passing of the Irish Church Act, 1869, he was engaged in almost every case of importance before the Church Commissioners. At the invitation of Judge Warren he accepted the post of Chief Registrar to the Probate Court on the retirement of Mr Keatinge. In the reorganisation of the Irish Church, Mr Pilkington has done service as a member of the Synod.

Mr Henry Charles Warren, Barrister at Law, son of Judge Warren, and who for several years filled the position of Judge's Registrar, has been appointed Chief Registrar.

Mr Robert Travers, Barrister at Law, Assistant Registrar, has been advanced to the position of Judge's Registrar.

Mr Thomas Jacob Geoghegan, M.A., who was called to the English Bar in 1871, and to the Irish Bar in 1872, has been appointed Assistant Registrar. Mr Geoghegan was a member of the North East Circuit.
