## DEATH OF THE BISHOP OF KILLALOE.

The Venerable William Bennett Chester, D.D., Protestant Bishop of Killaloe, died at 74, Harcourt-street, Dublin, yesterday afternoon. Dr. Chester had been in bad health for a considerable time past. His diocese was a very large one, comprising the united sees of Killaloe. Kilfenora, Clonfert, and Kilmacduagh. It contains over a million acres extending into the counties of Olare, Galway, King's County, Queen's County, and Tipperary. He was son of the Rev. John Ohester, M.A., Rector of Ballyclough, and was consecrated Bishop on January 16th, 1884. His early education was received at Ennis College, of which the late Rev. Dr. King was principal. Entering T.C.D., he passed through his Arts course, won many distinctions, including the medal of the College Historical Society, four 1st Vice-Chancellor's Prizes and Honors in Hebrew. He took his B.A. degree in 1846, his M.A. degree in 1847, and his B.D. and D.D. in 1883. His first curacy was that of Kilrush, to which he was ordained in Christ Church Cathedral. and subsequently he was in turn vicar of Killard. rector of Ballymackey, rector of Kilkee, rector of Nenagh, and rector of Birr. He also held the dignatories of Canon of St. Patrick's, Rural Dean, Chancellor of the Diocese, Archdeacon of Killaloe, and Chap'ain to the Viceroy. He was Archdeacon of Killaloe in November, 1883, when the late Right Rev. Dr. Fitzgerald, Bishop of Killaloe, died, and at a meeting of the Synod of Killaloe, held at Limerick, Dr. Chester was elected to succeed him. In all the parishes over which he had charge he effected permanent improvements.
