DEATH OF THE REV O P KENNY, P.P., FEDAMORE.

The Rev C P Kenny, P.P., Fedamore, died on Sunday night at 5 Lower Mallow-street, after a lengthy illness, much regretted by his parish- ioners and all who had the pleasure of his acquaintance. He was a most zealous clergyman, as several permanent buildings in his parish, which he was instrumental in establishing, so amply testify. The rev gentleman also success- fully interested himself on behalf of the tenants on the Leconfield estate in the purchase of their holdings. He was born in 1831, in the parish of Tournafulla; studied at Rome and Maynooth, and was ordained priest on the 23rd September, 1860. He ministered as curate in the parishes of Feenagh, Ballingarry, Kiltuane, Shanagolden, Newcastle-West, and Bruff, and in July, 1882, he was appointed Parish Priest of Fedamore. The funeral is to take place at Fedamore at 11 o'clock to-morrow. The remains were removed to Fedamore this evening. A large number of clergymen were present, as well as several citizens, including Dr Barry, Mr F W McCarthy, Mr W F McNamara, Mr P J Lynch, C.E. Mr J G Kelly, J P, Fedam- ore, with a large number of residents of the Parish, attended, and there was a long line of vehicles.

DEATH OF MR JAMES EWART.

We deeply regret to record this evening the wholly unexpected demise of Mr James Ewart, Secretary of Messrs Spaight and Sons, Limited, which took place at his residence, Lower Mallow street, on Sunday evening, after a few days illness. The news of this young gentleman's death came completely as a shock on his very many friends, who regarded his illness as of a mere temporary character, and possessing nothing of a dangerous turn. Providence has decreed otherwise, and there has been removed from us in the bloom of manhood, one who, by his genial, happy, and un-assuming manner, won for himself a very large circle of acquaintances, as well as the confidence and esteem of all with whom he had dealings through life. Mr Ewart distinguished himself in the athletic field, having been for years connected with the L A A & B C. He was also connected with the Limerick Boat Club, while his strong physical powers were frequently seen to advantage at many fires in the city, he having been one of the most prominent members of the Merchants' Fire Brigade, as it then existed. His whole business career has been spent in Messrs Spaight's office, where he was most popular with all the employees, and that he was a most efficient officer, is proved by the fact that he was recently appoint-d secretary, which was a very responsible position for a young man of his age to occupy. The death of one who had before him such a bright career is deeply deplored, and the greatest sympathy is expressed with his respected family in their affliction. The funeral will leave for St. Munchin's Churchyard at 9 o'clock to-morrow (Wednesday) morning.
