THE more important Irish Banks have lost no sime in issuing their reports for the half-year inding 31st December, 1892, and the results how a condition of prosperity which is most atisfactory, not only to the shareholders, who ire primarily concerned, but to the country at arge. There has been a good deal during the ast half year which would tend to foster a tate of depression, but this does not seem to e reflected in the financial statements just published by our Irish Banks. The Bank of Ireland some few days ago announced a lividend at the rate of 111 per cent per innum, and the report is to be considered tonorrow by the general court of proprietors. Having provided for all expenses, bad or doubt-'ul debts, &c., and writing down bank premises y £1,865 0s 9d, the balance remaining to redit of the profit and loss account (including sum of £6,580 17s 10d brought forward from ast half year) amounts to £163,654 8s 4d, out of which the Board recommended that a lividend of 52 per cent, free of income tax, be now declared for the half year, payable on the Ist proximo (being at the rate of 111 per cent per annum), which will absorb a sum of £159.230 15s 7d, and leave a sum of £4,423 12s 9d to be carried forward to next half year. The National Bank has declared a dividend of 10 per cent per annum, or 10s per share. The profit and loss account of the bank for the half year ended 31st December, 1892, shows a balance of £92,896, 3s 11d available for distribution. The dividend absorbs £75,000, leaving a balance of £17,896 3s 11d, of which amount £3,610 8s 4d, being the dividends received on the rest or undivided profits, has been credited to the account, and £14,215 15s 7d to profit and loss new account. The rest will now stand at 2271,347 2s 2d. The Provincial Bank is not behind hand, and gives a very satisfactory account of its business for the last half year. Including £7,248 10s 11d brought florward from last account, there remains a profft of £41,279 13s 10d.

MILITARY FUNERAL-The remains of Private Devine of the Black Watch, who died at the New Barracks on Tuesday from natural causes were interred yesterday with full military honours. The coffin which was covered with the Union Jack, and bore the bonnet and sword of the deceased, was placed on a gun carriage drawn by four horses of the Royal Artillery. Preceding it was a firing party. The band of the Black Watch, and the company to which deceased belonged comprised the remainder of the cortege. The "Dead March in Saul" was played en route to the graveyard.

SUICIDE AT THE NEW BARRACKS.

A painful sensation was caused at the New Barracks yesterday morning, when it became known that one of the non-commissioned officers of the 2nd Batt. Black Watch, which is about to leave for Glasgow, had attempted to commit suicide. Inquiries elicited that Provosi-Sergeant James Milne was missed by his wife from his room between four and five yesterday mornings her attention having been first attracted by some moaning in an adjoining spartment The door was found locked, and the matter was reported to Sergeant-Major Baldwin, who with Sergeant Sherwood, of the who, with Sergeant Sherwood, of the Army Medical Department, at once went to Milne's quarters, and bursting open the door found the man lying in a pool of blood, with a razor close to him. He had a clean cut across the throat, the larynx having been completely Sergeant Sherwood staunched the severed. blood, and the doctors were sent for with all speed. Surgeon-Major Gormley and Surgeon-Lieutenant O'Reilly quickly arrived, and having done all they could for the unfortunate man, he was removed to the Military Hospital, where he lingered until about eleven o'clock this morning, when death relieved him of his sufferings. Deceased was a Scotchman and about 35 years of age. He had twelve years' service. during which time he served in Egypt, and was awarded the Soudan medal and chaps, and the Khedive's star. Latterly, he had suffered from pains in the head, but the general belief is that a religious mania was the cause of the desperate act. The Coroner has been communicated with, and an inquest will be held to-morrow. Deceased was a most popular and exemplary man, and his sad end is deeply regretted by his comrades and civilian friends. He leaves six young children to mourn his loss.
