Mr D P Sarsfield then took his place, and was brought by Mr Redmond over a field of examination that has now become quite familiar to those who have followed the history of the case. He was questioned closely as to his source of income, and admitted that he had at one time made much money by billiards and cards. With the re-examination of Mr Sarsfield the business of the day closed.
