# SERIOUS ROW OVER A COTTAGE.

## SEVERAL PEOPLE INJURED.

Pitchforks, scythes, and hatchets were, it is alleged, freely used, and some very nasty wounds have Murphy was been sustained on both sides. severely stabbed on the arm, and sustained a severe scalp wound. His wife, who also took part in the row, got a very dangerous wound on the temple, and the two Connells have some nasty wounds on various parts of the body. When the police arrived on the scene they found the house besmeared with blood, and the weapons of wartare strewn around in all directions. The parties had their wounds dressed last evening by Dr Hannigan.

#### A FARMER KILLED BY LIGHTNING IN COUNTY LIMERICK.

Yesterday a respectable farmer named O'Gorman residing a short distance from Rathkeale, was killed by lightning. The deceased was engaged making a rick of hay, for which purpose he was using a steel fork, which, it is supposed, attracted the electric fluid. The poor man was instantly killed.
