DEATH OF A BANK MANAGER—The death is announced of Mr William F Evans, Manager of the National Bank, Dungarvan, where he has been located in that capacity since 1882. He was the eldest son of the late Mr. William Evans. solicitor. Limerick, and for 30 years had been in the service of the Bank. By the people of Dungarvan he was most highly esteemed, and his death is deeply regretted. The funeral was of very large proportions, and the chief mourners were Messrs Arthur and Herbert Evans, and the Rev W Evans, White Church,

ASSAULT ON A SOLDIER.—Corporal Wm. Hoey, of the Royal Irish Regiment, was attacked and badly beaten by some persons unknown in Thomas street last night. It is stated that the corporal, accompanied by a civilian friend, Patrick Murphy of Carey's Road, was passing through the street about half-past 10, when some persons approached from the bowway of Tucker's botel and assaulted both. The soldier was knocked down, and it is alleged received some knocks on the face, causing an injury to the left eye, breaking two teeth in the left jaw, and causing a wound on the nose. The civilian was also beaten, but not so severely as the corporal.

A LIMEBICEMAN KILLED IN KINGSTOWN.—A very distressing accident occurred on Saturday evening on the Main Drainage Works, Eden Road, Kingstown. It seems that two men named Joseph Gaynor, aged 30 years, of 6 Finegan's Court, married, and James Mangan, aged 22 years, of 6 Ball's Court—a native of Limerick—were amongst those engaged in the work, and their charge missed fire. They proceeded to abstract the tonite from the boring, when it suddenly exploded, dashing the poor fellows about and burning and mangling them fearfully. They were conveyed to St Michael's Magnital with all possible departs by and it was Hospital with all possible despatch, and it was found that Mangan's right thigh was broken in several places and that he had received other injuries which rendered his recovery impossible. The poor fellow died on Saturday night, and his colleague lies in a precarious condition.

ACCIDENTS.—Michael Ryan, labourer, of Vize's Field was admitted into Barrington's Hospital on Saturday morning, suffering from a fracture to his right leg caused by a fall; he is detained in hospital. Another labourer named Denis Cleary is also being attended to in Barrington's Hospital, suffering from a fractured arm, and he also received wounds on the head, during a row. A man named Harry Ryan is in custody charged with inflicting the injury with an iron bar. Agnes Connors, a little girl residing in Francis street, accidentally fell downstairs on Saturday morning and fractured her thigh; she is detained in Barrington's Hospital. Yesterday morning an old woman was conveyed to the hospital complaining of injuries received by being run over by a farmer's cart in Upper William street, at eleven o'clock. She was found to have received very slight injuries, and was sent to the Workhouse Hospital.

CITY POLICE COURT.—No magistrate attended the City Police Court yesterday. Constable Riedy charged a man named John O'Brien, who wore a military uniform, with being a deserter from the Leinster Regiment. He was brought before Mr S B Quin, who ordered him to be handed over to the military authorities.—Mr Hickman attended at the City Police Court to-day. Sergeant Hickey applied for the remand of a labouring man named John Clery, for assaulting his mother. The sergeant stated that he saw the prisoner strike his mother in the face with his

LICENSING APPEAL.

Mr Corneilus Quilligan, publican, John-street, appealed from the decision of the city magistrates imposing on him a fine of £2 for a breach of the Licensing Act.

Mr Leahy represented the Crown, to sustain the conviction, and Mr J H Moran, solr, appeared

for the appealant.

From the evidence of Constable Daly it appeared that on the occasion in question the defendant's house was open, and three parties were drinking at the bar, at a quarter to two o'clock, it being Sunday. The defendant insisted that it two o'clock, but his own clock represented WAR the time as a quarter to two. which was right, as witness looked at his watch.

The defence was that the defendant was under the impression that it was two o'clock, and it was further urged that the police were unfriendly

towards him.

Head-constable Feeny was examined and

denied the latter allegation.

His Honor in endorsing the conviction of the magistrates said in his opinion the defendant was aware that it was not two o'clock, and he did not believe that the police had any spite against The bench of magistrates who heard the case had exercised a discretion in the matter, and he would not disturb that discretion. He would do everything that he could to support the action of the Limerick magistrates in dealing with this question of licensed houses, because he believed their attitude in the matter courageous, straight, and most useful, a great example to other places, including the county of Limerick. By the manner in which the city magistrates were dealing with this mos useful licensing code they were an example to the magistrates of other counties, including, he must say, the county of Limerick. In this case the conviction and fine were confirmed.
