An order was then made directing the Board's solicity: to take proceedings against the tenant for recovery of the cottage, and postponing action in the case of another cottage in order to receive applications from persons willing to pay the arrears, a letter having been read from Michael Manon agreeing to pay portion of the arrears. Canny, the late tenant, also wrote agreeing to pay on a month towards the arrears, and the way of 4s 4d a month.

IMPROVEMENTS IN THE HOUSE.

The Clerk submitted an estimate for fitting up a service of electric bells and ordinary bells from the several wards to the master's apartmente, and also for exection in the infirmary. He said there were no means of communicating with the master in case anything occurred during the night in any of the wards, and a committee had recommended that bells be erected from the wards to the master's apartments, the architect being directed to give an estimate of the probable cost. The Clerk then read the report of the committee on the subject.

The Local Government Board wrote asking to be informed what steps were being taken in reference to the recommendations of the committee with respect to the appointment of a female night nurse.

The Clerk said that the committee that met on the 19th August had recommended a female night nurse as just as necessary as a male night nurse, and it was ordered by the Board that a female night nurse be advertised for, but he could not do so until he knew what salary to off-r and the other emoluments she was to get. He wished they would now settle what was to be her salary and age.
