A watch found in the vest proket was stopped at 6-7 o'clock. This afternoon an inquest was held in the City Courthouse by Mr Coroner DeCourcy, and a jury, of which Mr Michael McGrath was foreman. The inquiry was conducted by Head Constable Feeney. Evidence was given by Michael Cosgrave, Herbour employee, that he found the body at Russell's Quay at eleven o'clock this morning. Mrs Mary Hayer, sister to the deceased gave evidence of identification. Dr Shanahan, who made an examination of the body, stated there were no marks of violence, and death resulted from drowning. The jury returned a verdict accordingly.
