SAD DROWNING ACCIDENT.

Yesterday evening an inquest was held by Mr Coroner DeCourgey at the residence of Mr Michael McDonnell, T.C., Nicholas street, on the body of Bernard Matthews 131 years, son of a gardener, who was drowned on the previous evening in the river opposite the public baths. From the evidence it appeared that some comrade boys of the deceased procured a small disused boat which had been lying in the yard of Mr Matthews, and launched it in the river below the baths. The craft soon began to fill, and the boys returned to the bank. Afterwards the deceased and a boy named Barnes embarked on the hoat, and proceeded up the river. The boat soon got filled with water and began to sink, and eventuelly went from under its occupants, who were left to struggle in the water. The deceased's brother, Wm Matthews, who was on the bank, went to their assistance, and caught his brother, but they both went under water, and in order to save himself he was forced to push his brother away. He called for assistance to a man named Carmody, who, however, seemed unable to render any sid. A boy named Ryan, who was attracted to the occurrence, undressed and swam to the assistance of Barnes, to whom he pushed the capsized boat, enabling him to get ashore. The body of the boy Mutthews was found yesterday morning by a man named James Conway. The foreman, Mr M McDonnell, having commented on the absence of life buoys at the place, the jury returned a verdict of accidental drowning, and recommended the conduct of Wm Matthews and Michael Ryan to the consideration of the Royal Humane Society.
