DEATH OF CLORANE.

Clorane, whose name will (remarks the *Independent*) be remembered for many years to come as a race horse of exceptional worth—in fact, a record breaker—died at the Foxhill Stud Farm, Tuesday morning. Clorane was by Castlereagh (by Speculum), dam May Girl, by Victor, from May Day, by Lucas, and was bred by Mr J G Hartigan in County Limerick in 1891.

The magistrates present were Mr Hickson, M., and Mr W. F. O'Grady.

Kate O'Halloran, an inmate of the union, was charged by the Master (Mr Dundon) with having refused to obey the reasonable orders of the landlady.

She had then two children with her in the Union, and when she came out of jail recently she did not go to the Union for the children, and these could not be legally detained there with her. She is now required either to go back to the Union or take out the children. The case was adjourned for a week to give her an opportunity of acting as required.
