

FISHING AT KILLALOE—Mild dry weather is being experienced, and the river is in nice fishing order. John Lyons and R. Johnson, got a peal, 7lbs, Mr F. C. DEATH OF THE VERY REV FATHER MOORE, S.J.—The death is announced in Australia of the Very Rev. Father Moore, S.J. The deceased was a native of Kilkee, Co. Clare, and was for some time attached to the Jesuits' Church in Limerick, where he was greatly esteemed. Father Moore was a man of marked ability, having occupied the position of Prefect of Philosophy at Stoneyhurst College, and he also filled the important office of Vice-Rector of the Catholic University, Dublin. Of late years he had been engaged in mission work in Australia. In Limerick and Kilkee the news of Father Moore's death will be heard of with feelings of the deepest regret by all classes.

DEATH OF THE REV W. F. SEYMOUR, ABINGTON.

We regret to announce the death of the Rev W. F. Seymour, A.M., who has held the post of Incumbent of Abington since 1872. The Rev Mr Seymour was one of the most popular clergymen in the neighbouring Diocese of Cashel, and was no less highly esteemed by his brethren of the Diocese of Limerick, where a considerable portion of the early years of his ministry was spent. He was a most kind and amiable gentleman, a sound scholar, and earnest and devoted in discharging the duties of his sacred calling. Some short time ago he had been promoted by the Bishop of Cashel to a dignified position in the Chapter of Cashel Cathedral, but finding that the state of his health would interfere with the performance of the duties attached to his office he resigned the dignity and the emoluments connected with it. His death will be heard of with extreme regret by a wide circle of friends, who recognised his worth as a high-minded gentleman and faithful pastor.

THE CHESHIRE REGIMENT.

This morning a detachment of the 2nd Battalion Cheshire Regiment, consisting of 100 men, left Limerick by the 7 o'clock train for Cork, to embark for India, where they join the 1st Batn. at Secunderabad. The detachment was in command of Major Strahan, of the Royal Inniskilling Fusiliers (who takes the place of Captain Frazer) and Second-Lieutenant Howard. No interest attaches to the movement beyond the fact that the detachment goes to make up the full strength of the battalion. Their place in Limerick will be gradually filled by recruits. The men were played to the terminus by the regimental band, accompanied by a crowd, and were loudly cheered.

entered a dwellinghouse in Dublin on the 4th August, with felonious intent. The circumstances of the arrest which was cleverly effected by Sergeant McAree, Dock station, are well known.

Mr P. Kelly, B.L. (instructed by Mr P. O'Sullivan, solicitor), appeared for the accused. Unfortunately, he said, she was married to a very drunken husband—a man always saturated with drink; and always ravenous for it. She had six children, ranging between the ages of ten years to the infant she carried that time in her arms. The children were starving around her, and really she was guilty of this offence not from criminal intents, but the instinct to keep her poor children from starving. For a year and a half he understood she had not touched drink notwithstanding her temptation—

His Honor—That does not explain why the bottle was found in her pocket, which I am sure was half full at the time (laughter).

Mr Kelly, continuing, said the children were now motherless for two or three months, and would be so a great deal longer unless his Honor took a merciful view of her circumstances on their behalf. In the interests of the community at large, in the interests of her children, and in the interests of this woman herself, struggling against awful odds, he would ask his Honor to take a lenient view of the case.

His Honor, in sentencing the accused, said he was about to do a very weak thing. This was a woman who committed countless crimes—she was a robber. Her husband was a respectable member of society, because he beat her for his crimes and then shared her booty (laughter). He would only sentence her to a short term of imprisonment, and if she ever came before him again as sure as that clock was before him he would send her to gaol for five years penal servitude. He now sentenced her to three months imprisonment from the time of her committal.

COMPLIMENT TO THE POLICE.

His Honor, resuming, said this crime of entering houses which have been left uninhabited by people going to the seaside was a most mischievous work, and was practised on a large scale at Dublin some years ago. In the present case he thought the promptitude with which Sergeant McAree arrived on the scene, tracked this woman from the house in which she had been originally to the house in which she was captured—all in a few minutes—showed he was an ornament to the force, and he hoped his Honor's terms of appreciation would be conveyed to his authorities.

District Inspector Hetreed said that owing to Sergeant McAree's vigilance in this locality the police had been able to largely put down nocturnal burglaries during the year. Although the Night Watch were in charge, and although they were out this particular night, he found Sergeant McAree to have six night patrols in the week during the summer months for the object of putting down this class of crime.

His Honor—Are they doing night duty now?
District Inspector Hetreed—Not as a matter of right, but merely as a precaution I send out a patrol every night.

His Honor—Very right.
District Inspector Hetreed said he would have great pleasure in bringing his Honor's commendation of Sergeant McAree under the notice of his authorities.
