As those in charge had no authority to grant this, nothing was done for some time, and the labourers subsequently demanded an increase of half a crown, which the Limerick Steamship Company declined to pay. The same thing occurred with the Lizzle, belonging to Hesers Mullock & Co, coal merchants, which now lies in the dock with full cargo. The "Kincora" is being slowly unloaded by a few men in the regular employment of the dompany without any interference from the dockers. Two gangs of men refused to work for Messrs Bannatyne, whose storemen have joined the strikers. The "Garryowen" elevator has been taken down the river for the purpose of lightening a big ship belonging to the firm, and the work will have to be done by sailors. During the day the labourers gathered in groups in the vicinity of the Docks, but no unpleasant incident occurred.
