THE LATE MR. JOHN ELLARD

We record with very sincere regret the death of an old and very prominent citizen, Mr. John Ellard, Solicitor, Clerk of the Crown and Peace for the City and County of Limerick, which took place yesterday afternoon, at his residence, 80, George street. Mr. Ellard's illness was brief, for as late as this day week he was apparently in his usual good health, and had been at his office transacting business. However, on Sunday night, he was attacked with a paralytic stroke on the left side, and from the outset very little hope was entertained of Mr. Ellard's recovery, having regard to his advanced age 82 years. His condition grew worse, and despite the medical skill of Dr. Malone, the end came yesterday between three and four o'clock. Mr. Ellard came of an old Limerick family, his father having been a cloth merchant in Patrick-street, in what are regarded as the "good old days." His son showed an aptitude for legal pursuits, and having served his apprenticeship to Mr. Henry O'Shea, of this city, father to Captain O'Shea, ex-M.P., was admitted a solicitor in 1845, and from thenceforth enjoyed a very extensive practice in his native city. Railways were then in their infancy, and it is interesting to remark that for some years Mr. Ellard, with Mr. Kane, Solicitor, another Limerick man, was actively en gaged in the promotion of local Railway Bills, and for a number of years afterwards he was Soli eitor for the Waterford and Limerick Railway Company. Perhaps it was in connection with politics that Mr. Ellard was hest known. Though an ardent Liberal, he was very unobtrusive in his views; but he was an excellent worker, and where hard electioneering work had to be done, Mr. Ellard was in the thick of it. In the many notable Parliamentary elections for the city and county which took place during the past fortyfive years, the conducting agent for the Liberal, or the subsequent Home Rule candidates was Mr. Ellard—at least up to eighteen or twenty years ago. To come down to the familiar elections, it may be mentioned that he acted for the late Mr. W. H. O'Sullivan in his fight against Mr. Roche-Kelly. He was one of the first to take up Mr. Isaac Butt in Limerick, for which city he was returned member of Parliament, and he was later on conducting agent for Messrs. O'Shauganessy and Gabbett against Sir (then Mr.) James Spaight. Mr. Ellard, it may be added, was on interest to may with the late. Token Bright, and land timate terms with the late John Bright, and on the occasion of a visit to Limerick thirty years ago was instrumental in organising a public demonstration and a banquet in honour of the great politician and economist. Turning to municipal life, Mr. Ellard became a member of the Corporation some years after the passing of the Reform Act of 1840, and about 1855 was appointed Town Clerk, which position he held till 1882, and in connection with which his sound judgment and undoubted business capacity, combined with a genial and kindly manner, were highly appreciated. On the death of Mr. John Synan, Mr. William M. Beauchamp, solicitor, was appointed temporary Clerk of the Crown for the County in 1877. Then in 1882, Mr. Moore, Clerk of the Peace, died, and Mr. Ellard was appointed by Lord Spencer, then Lord Lieutenant of Ireland, to the united offices, which now became amalgamated under the County Officers' Act, and Mr. Ellard, with his usual ability, discharged the duties uninterruptedly up to the time of his illness. It need hardly be said that Mr. Ellard was a great authority on local contemporary history, and a most interesting raconteur. He was a great favourite with all classes, and though he had passed the allotted span of three score years and ten, his demise is deeply regretted. DEATH OF MR. T. M. BOURKE.

Mr. Bourke was a gentleman who through his long and active life was associated with every good work.
