RIOTING IN GRIMSBY.

Rioting was resumed in Grimsby this morning. A large crowd assembled outside the old offices of the Owners Federation, and a number of youths. practically massociated with the fishermen and engineers, commenced storming the building Chief Constable Starling and some dozen officers exhorted the mob to desist, and threatened to send for reinforcements if the disorder continued. This was greeted with ironical cheers, and the crowd next proceeded to the offices of Hagerna, Doughty, and Co., of which the borough member is partner, and smashed every window in the Mr. Walter Wood (Chairman Disputes Committee), Mr. Collins (Engineers' Secretary), Mr. Bennett (Secretary of the National Union), Mr. Carruthers (of the engineers), and Mr. Porteous (Chairman Relief Committee) got between the mob and the offices, and after some trouble Mr. Wood succeeded in addressing the crowd. He pointed out that the disturbances were bound to alienate public sympathy and lose the men's case. His remarks had the effect of subduing the outbreak, but the attitude of the mob is very threatening

Owing to a request for assistance, Commander Scott, Chief Constable of Sheffield, has sent three iuspectors and 180 men to Grimsby.
