THE FOYNES TRAGEDY.

PRISONERS AGAIN REMANDED.

At a special Court held at Foynes on Thursday last before the Hon. J. French the three young men named John, James and Michael Green were brought up in custody charged with the wilful murder of Michael Sheehy, a milesman, in the employment of the late Waterford and Limerick Railway Company, under circumstances which have already been published.

Mr. William Leahy, Crown Solicitor, assisted by County Inspector Hayes prosecuted.

Mr. John Condon, solicitor, defended the accused.

Dr. Nolan deposed that death accrued from a wound which could be caused by the knife produced, but it would require considerable force to cause the penetration.

At this stage Mr. Leahy asked for an adjournment until Saturday, which was granted.

To-day at the County Prison, Limerick, the hearing of the case was resumed, further witnesses being examined, and the prisoners were again remanded.
