A communication was read from Mr. Willis, Agent to Colonel Massy Studdert, relating to a dangerous quarry on his property in Cooraclare, in which a drowning accident occurred through its exposed condition, and stating that he had written to the landlord with a view to its being fenced in.

Mr. Murphy: The agent has now given instructions for its being walled in.

The Chairman: I had no doubt he would do so.

SANITARY.

In reference to a communication from Father Hogan, C.C., calling for the abatement of a nuisance near the Court house, Kilkee, by a main sewer connection, read at last meeting, a further report was read from the Medical Officer, Dr P.P. Hickey, J.P., to whom the matter was referred, stating that the work was an imperative necessity, as a bad condition of things existed.

Mr. D. Casey said there were three nuisances on the spot, and it was perfectly dangerous.

An order was made that the landlord and occupier of the premises be noticed to put the place in a sanitary condition.

THE FLOODS.

The Chairman moved the following:—Resolved—That owing to the great damage done by the recent floods to farmers and occupiers of small holdings in our Rural District, we respectfully call upon the landlords of such districts to come to the rescue of such farmers and occupiers, etc., by recouping them in their loss in such times as the present.

On arrival at St. John's the coffin was borne into the church and, owing to the heavy rainfall, the greater part of the service was conducted there, the officiating clergy being the Rev. F. W. Glyn, vicar of Braneopeth; the Rev. Canon Ross-Lewin, St. Cuthbert's, Benfieldside, and the Rev. R. W. Wilson, vicar of St. John's. A muffled peal was rung by the St. Cuthbert's (Benfieldside) ringers before morning and evening service on Sunday, in memory of Mrs. Walton-Wilson, and the Dead March was played by Mr. G. P. Stephenson, organist of St. Cuthbert's, Benfieldside.

BURNING FATALITY IN THE CITY.

Yesterday an inquest was held at Barrington's Hospital by Mr. Coroner DeCoursey touching the death of Wm. Keogh, 4 years old, living with his parents in Clare street, and who was admitted to the hospital on Saturday night suffering from burns.

Head-Constable Moore, John street, conducted the inquest on behalf of the Crown.

Mrs. Catherine Keogh, Bowles' Lane, Back Clare street, mother of the deceased, deposed that between seven and eight o'clock on Saturday she left her home to do some business; she took one of her children with her and left the eldest boy in the house; she did not leave anyone with the boy; there was a small fire in the grate in the house; she went to a shop about eighty yards away, and while on her way back within a few minutes she saw him ablaze in the lane-way; she threw her shawl around the boy and extinguished the burning clothes which he wore; he was then taken to hospital; this was the first occasion on which she left him alone in the house; her husband is away from home.

Dr. McGrath stated that the boy was admitted to the Hospital about eight o'clock on Saturday evening. He was suffering from extensive burns on the legs and abdomen. He died that morning at four o'clock, death being due to shock.

John O'Grady, labourer, in the employment of the Corporation, gave evidence that he saw the boy's clothes on fire. The boy's mother had wrapped her shawl around him, extinguishing the burning clothes. Witness immediately tore the clothes off the boy, and applied some sweet oil to the burns, and then carried him to Barrington's Hospital.

The Coroner said the reason why the inquest was necessary was that there might have been neglect on the part of the mother, but the evidence furnished no grounds for such a supposition, as the mother had only gone out for a few minutes, leaving a very small fire in the house, and was under the impression that no danger existed.

The jury returned a verdict of death from shock, resulting from burns accidentally received.
