QUESTIONS IN PARLIAMENT.

In the House of Commons yesterday. Mr. O'Shaughnessy asked the Chief Secretary whether he was aware that a resolution was unanimously adopted by the Town Commissioners of Newcastle West, in the county of Limerick, calling attention to the public inconvenience caused by the Great Southern and Western Railway Company neglecting to provide a more improved service between Limerick and Kerry, and stating that it was on the faith and guarantee of said company that a better train service and facilities to the public would be given; that the representative bodies in the South of Ireland along the system favoured this amalgamation; and whether, in view of these facts, he will see that the Great Southern and Western Company provide a better service? The Chief Secretary—There has been no material alteration, and therefore, I conclude, no improvement on the section of the line referred to. It is, however, only right to add that extensive improvements have been effected in other parts of the system since the amalgamation. I am not aware that any undertaking was given by the company to the specific effect mentioned, but the general manager has always shown the fullest desire to consult the conveniences of the travelling public, and will, I have no doubt, exhibit it in that case. Mr. Flavin asked if the right hon. gentleman was aware that owing to the promises which were made to them the people of North Kerry and Limerick withdrew their opposition, and that these promises had not been fulfilled? SAD DEATH OF AN INSANE PERSON.

THE INQUEST.

Mr Coroner De Courcy held an inquest at three o'clock yesterday on the body of Ellen O'Brien, Caharnagh, Kilcoleman, who was committed to the District Lunatic Asylum on the 16th instant, and died in that institution on Thursday.

Head Constable Fitzgerald represented the police.

Patrick O'Brien, farmer, Caharnagh, Kilcoleman, deposed that the deceased was his wife. She was committed to the Limerick Lunatic Asylum as a dangerous lunatic on the 16th inst. In May she strayed away from home, and was taken to the Limerick Workhouse Hospital. On her return her manner was odd, and he saw she was insane. He watched her as far as he could. She did not sleep at night. She hinted at doing away with herself. On Monday, July 8th, she was vomiting, and told the children she had the job done. He had corrosive sublimate in the house, and at the end of the week witness's said daughter she was afraid her mother had taken poison. Witness went for Dr. Nolan, of Shanagolden, and he came to see her. She said she had taken medicine to do away with herself. Witness told the doctor he thought she had taken corrosive sublimate, as he found an empty packet which contained the poison, and which he had removed from the room in which she slept. There would be about fourpence worth of it in the packet when he saw it. He hid the packet under bedclothes in a box in his own bedroom. He used the poison when cutting calves. Deceased appeared to be all right after the doctor saw her, but she was weak. He heard on Friday that she had taken poison and he went for the doctor on Sunday, the 14th July. She told the doctor she would do away with herself and she had tried to drown herself two days after she took the poison. Her clothes were found in the kitchen all wet, and she stated that she had tried to drown herself but could not get enough of water in a stream on the farm.

Ellen O'Brien, step-daughter of the deceased, deposed that she did not know where deceased was going when she strayed away. She was always talking about religion. Witness knew where her father kept the poison. Deceased also knew. Witness also saw it in her father's room. Deceased was vomiting on July 8th and told witness she had taken the poison. Witness went to the box and found the empty paper there. Deceased warned witness not to tell her father and she did not do so. She was afraid. Witness told him on the 12th instant. Deceased told witness she had tried to drown herself.

Sergeant Farrell deposed that on the 15th inst. Pat O'Brien told him that his wife was suffering from religious mania, and had attempted to drown herself. Dr Nolan examined deceased. On the 16th instant witness met the doctor, who informed him that deceased had taken as much corrosive sublimate as would have killed several people, that deceased told him she had taken the poison, and that she said if she was not put under restraint she would do away with herself. Witness saw that she was taken to the asylum.

Ellen Hannan, nurse in the asylum, deposed that deceased was very weak when admitted and scarcely able to stand. The doctor saw her, and she was ordered to be put to bed. She was very quiet. Witness gave her beef tea, and deceased vomited immediately afterwards, and said she had taken poison—a wash for calves.

Dr. Coffey, Assistant Medical Superintendent of the Asylum, deposed that deceased was admitted on the 16th. The information on which the committal was granted was that she had attempted to commit suicide by drowning and poisoning. She was very weak, and said she had taken corrosive sublimate for a pain in her shoulder. Every effort was made to give her nourishment, but she died from exhaustion yesterday. Death was due to exhaustion, resulting from the acute inflammation of the stomach and bowels. Witness agreed with Dr. Nolan that deceased had lived so long that on account of having taken such a large dose she had vomited part of it. She was suffering from acute melancholia. The jury returned a verdict in accordance with the medical evidence, adding that the poison was self-administered.

WATER IN BUTTER.

PROSECUTION AT ENNIS.

At Ennis Petty Sessions yesterday, before Messrs. H. B. Harris (in the chair), A. N. Brady, R.M., and P. J. Linnane,

Sergeant Sullivan, local Inspector under the Foods and Drugs Act, had a farmer named Patrick Crowe, of Bushy Park, summoned for having at the Bannis market, exposed for sale, butter which was found on analysis to contain 21.8 per cent. of added water.

The Sergeant proved the purchase of the sample, and produced Sir Charles Cameron's analysis.

The Chairman read a resolution of the Clare County Council, in which magistrates were asked not to convict in cases of 20 per cent. of water, or under.

In reply to Mr. Linnane, the Sergeant said this was the first case of the kind he had.

Mr. Linnane—That speaks well for the butter of the district anyway.
