## DEATH OF MR. J. CLOSE. B.A.

We deeply regret to announce the death of Mr. James Close, B.A., which occurred at his residence Clare street, yesterday, after some weeks illness The sympathy and regret are accentuated by the fact that Mr Close was taken away when prospects were brightest, and when life should be in its prime. Mr. Close was about thirty-three years but hard work of age, but hard work had under-mined his health, and although unrelenting had in his studies and duties, he had been complaining for some months back. The late Mr. Close was a brilliant scholar, and a most successful teacher. In '83 he began as a pupil teacher in the Model School, and two years afterwards he went to Marlborough Training College and left as a first-class National School Teacher, a first-class National School Teacher, with several special certificates from the National Board. For some two years he acted as one of the principals at St Munchin's College, after which he established on his own account an Intermediate School, which he conducted with conspictious success, and it was only last week that two of his pupils passed with honors for the Boys' Clerkships, one of them taking tenth place in four hundred vacancies. the result of private study he took out his B.A. degree of the Royal University. Apart from his great intellectual gifts; the late Mr Close had many other qualities which endeared him to his acquaintances and a wide circle of friends. His genuality and generous heartedness made him a general favourite, and his advice and his assistance were at the command of everyone who sought them. His death is an irreparable loss, and the public will join with us in tendering to his young widow and five children our deepest sympathy in their singularly poignant sorrow.
