Mr. Long seconded the motion, which met with considerable opposition, and cries of "we don't want an old soldier in the chair," "we want Donnellan." Mr Long proposed that Mr. Donnellan take the chair, and a counter proposition having been made that Mr Vaughan take the chair a saw of hards, was taken, and a midde, a chair a show of hands was taken, and amidst a scene of much confusion, Mr Donnellan declared that the proposition that he should preside was carried. He then took the chair amidst much cheering, and briefly explained the objects of the

Mr. James Hassett proposed that the former Councillors again go forward, but the proposal met with disfavour.

Lleng, Mr John Kennedy, Mr John Slattery, Mr Daniel Donovan (who declined to go forward), Mr P. Dooley, and Mr Dineen. The names of Mr Connery and Mr Vaughan were also proposed and seconded, but they declined to be nominated by that meeting. that meeting,

Mr Vaughan attempted to make a speech, but could not be heard owing to the interruptions, and after a scene of much confusion Mr Donnellan declared that the following gentlemen had been selected by the majority of the meeting—T.
