Mr. J. H. Roche, J.P., seconded the resolution. Any tribute that they could pay to the memory of the late Mr. Cleary, would not be too much. He was respected and liked by all classes of the

community.

Mr. P. J. O'Sullivan, solicitor, said he regretted that one of the senior members of the profession was not present, but he was certain that they would join in this tribute to the memory of the late Mr. Cleary. He endorsed the remarks which had come from the Bench, and exceedingly regretted that they would not have Mr. Cleary amongst them again.

FOR PERSONAL CLAHM INJURIES.
