

tion of the constitution of the Irish Light House. The Belfast Harbour Commissioners wrote some time ago that it would be desirable that a commission from the principal Harbour Boards should be appointed by the President of the Board of Trade with a view to securing representation of Harbour Trusts on several Light House Boards of the United Kingdom. Mr. Boyd submitted copy of a Bill to amend the law with regard to light houses and the abolition of light dues. This Bill was proposed by the Liverpool Steamship Owners Association.

The clause which, he said, most interested the Harbour Board was No. 7, which provided that members of the English, Scotch, and Irish Light House Committees shall be appointed by the President of the Board of Trade, provided a majority of the English Light House Committee shall consist of persons representative of the shipping trade of England and Wales; and with regard to the Scotch and Irish Light House Committees—that they shall consist of persons representative of the shipping trade of their respective countries. Such persons, it was added, shall be appointed upon the nomination of such shipping trade Associations (or Mr. Boyd proposed "Harbour authorities") etc., as shall be determined by Order in Council.

Power would not be in favour of handing over the Irish Light House Board to Shipping Organizations. If they were appointed through the local authorities it would be a different matter.

Holliday asked what action Dublin would be taking in the matter.

Secretary said that the matter had been discussed by the Cork Harbour Commissioners, and they had referred it to the Finance Committee. Further consideration of the subject was not required.

HOLIDAYS.

Secretary and Harbour Engineer were granted their annual leave of absence, to be taken in intervals as would suit the convenience of the Board.

Harbour employees wrote requesting a half holiday on each day of the races.

It was agreed to give the employees the option of taking a holiday on the race day instead of one of the usual holidays.

Other business was routine.

G. Conyers on the 5th inst. and remanded for eight days. He was now, on the application of Sergeant Michael, further remanded by Mr. Hickson.
