"FARMING" A COTTAGE.

Newcastle District Council sued John Massey for possession of a cottage at Knockane.

Mr. Wm. Leahy, solicitor, Limerick applied for the Council and said that Massey held under a weekly letting of 10d per week rent, and they sought possession on the grounds of arrears, but the real motive or reason the Council had in getting possession was that Massey had assigned his interest in the place, and had he believed received the substantial sum of £5 for giving up the key. If the District Council were to tolerate such proceedings a regular traffic in those cottages would be established which they were determined to put down. He feared the present case was brought under the wrong section, it should be under a notice to quit.

The matter was adjourned to enable fresh proceedings to be taken.
