### MONEY LENDER'S ACTION.

#### JUDGMENT SET ASIDE.

Before the Court of Appeal, Dublin, an interlocutory appeal was heard in an action in which the Munster Private Loan and Discount Office, Limerick, were plaintiffs, and Mrs. Bridget Liddy, and John Liddy, of Rosroe, County Clare, were defendants. The plaintiffs in the action had obtained an order for final judgment before Mr. Justice Boyd in the King's Bench Division on the 23rd March last for a sum of £35 and costs on foot of a joint and several promissory note of defendants, and the matter came before the Court of Appeal on an appeal by said defendants from said order.

The Court of appeal on a consideration of the affidavits filed in the action, and after hearing Counsel for the parties reversed the order of Mr. Justice Boyd and set aside the judgment and execution thereon, with nine guineas costs to the defendants, who were allowed ten days to file statement of defence.
