SHOCKING RAILWAY ACCIDENT.

AT BALLYSIMON.

ONE MAN KILLED. ANOTHER SERIOUSLY INJURED.

The most painful railway accident which has occurred in this district for a considerable time past took place yesterday morning at Ballysimon Bridge three miles from the city, on the main line between Limerick and Limerick Junction. The matter having been reported in town a very short time after the tragic occurrence, our representative proceeded to the spot for the purpose of instituting inquiries. The information then available was not very full, but it would appear that for some months back a number of hands, skilled artisans and labourers, have been engaged putting together the materials of a new iron bridge, which, when completed, will be rolled into the place of the existing one. The new structure is on the left-hand or Limerick side of the road, while underneath the old bridge and on the public road at the other side of it, are various mechanical appliances and a quantity of timber necessary for the carrying out of the works. At either side of the old bridge on the permanent way is a curve of considerable length. Yesterday morning Matthew Dwyer, a labourer of Oola, Co. Limerick, single man, aged 22 years, and lodging in the city; Patk. Madigan, labourer, a native of Commons, Ballysimon, aged 21 years, and a third whose name we have not ascertained, were engaged carrying a plank from the new bridge, across the line, down the escarpment, and then on to the public roadway on the right-hand side as you look towards Limerick Junction. Having done so, they proceeded back, the third person reaching the place safely, but Dwyer apparently had just got on the up track when he was caught by an incoming train, and killed instantaneously. He appears to have been caught a few yards at the Limerick side of the bridge, dragged along for a distance of thirty-two yards. Portions of the brain were scattered here and there near the rails, his left leg was broken in two and shattered to pieces, and altogether the body was dreadfully mutilated, while his left arm was found three hundred yards from the scene of the accident, and his cap still further away. Madigan, who was the last of the three apparently was about stepping on to the line when the train came on him. He received a compound fracture of the right thigh, and he received a serious injury to one of his arms. He appears to have been flung back to the embankment, and thus escaped death. The moment the accident occurred, the foreman of the works at once sent word to Sergeant Callaghan at the Police Barracks close at hand, and he with Constables Prestige and McMorrow were on the scene in a moment. They had the remains of the deceased man placed in a sheet and conveyed to an outhouse in the village pending an inquest. They did everything possible for the injured man (and it may be remarked that McMorrow has a certificate in the ambulance class) pending the arrival of Drs. McGrath, Laird, and Coffey, who had come out from town with all speed, as also Father Murphy, C.C. In response to a telephone message the Fire Brigade men came out with a hand ambulance and carried the patient from Mrs. Arrahill's house, where he temporarily lay, into the Co. Infirmary. His condition is critical. Various theories are set forth as accounting for the deplorable calamity, one being that a desperately strong and icy wind blew right in the faces of the poor men from the north-west, they were unable to hear the approach or the whistle of a train at their backs. It is a melancholy circumstance that Dwyer's brother, who was a railway guard, was killed some twelve months or so ago. Head Constable Moore visited the scene yesterday afternoon and the facts of the case have been submitted to the coroner with a view to an inquest. The watch found on the deceased stopped at a quarter to ten which would show that that was the exact hour the accident occurred. It appears that the deceased had been all through the South African War. On enquiry at the Infirmary late this afternoon we were informed that Madigan is "going on splendidly considering his injuries." A rumour was spread in the city

ANOTHER RAILWAY ACCIDENT AT LIMERICK.

FATAL RESULT.

Following the distressing accident occurring at Ballysimon yesterday, came the news this morning of another shocking occurrence last night at the Locomotive Works of the Great Southern and Western Railway at Limerick. James Slattery, night shunter, while in the performance of his duties at about midnight was accidentally knocked down and the wheels of one of the carriages passed over his left leg shattering it in a dreadful manner. Assistance was at hand at once, and the Fire Brigade ambulance having been requisitioned the unfortunate man was conveyed to Barrington's Hospital. After a consultation between Drs. Holmes, Graham, and the Resident Surgeon (Dr. Waters), amputation was considered the only remedy, and the operation was successfully performed. The poor man, however, had lost a great deal of blood and gradually growing weaker and died about half past eleven this morning. The deceased was a quiet unassuming man, and was much respected by his fellow workmen and his employers. He was a widower.
