FUNERAL OF THE LATE MRS. WILSON

A NEW BOOK.

SOUTH OF IRELAND FAMILIES.

A new book which should prove of exceptional interest to our readers in the south and west of Ireland will be published by Hodges and Figgis of Dublin, on Wednesday next. It is entitled, "With the 32nd in the Peninsular and other campaigns," being memoirs of Major Harry Ross Lewin, of Ross Hill, in the County of Clare. The memoirs are edited by Mr. John Wardell, M.A., a reader in modern history in the University of Dublin, and Professor of Political Economy at the Queen's College, Galway, who is a cousin of the Rev. R. Ross Lewin, Rector of Kilmurry. This book, which casts many interesting sidelights on public affairs from 1793 to 1822, deals with the following subjects:—Life in an Irish Militia Regiment, 1793-5; the West Indian Expedition, 1796; the treatment of Irish rebels in 1798; the rising under Emmet, 1803; the Copenhagen Campaign, 1807; the Walcheren Expedition and the bombardment of Flushing, 1809; the Peninsular War, 1808—1813, including full descriptions of the actions at Roleia, Vimiera, Salamanca, Burgos, Orthes, and other engagements; the Campaign of the Hundred Days, including Quatre Bras and Waterloo; the Ionian Insurrection, &c., &c. The introduction contains a short memoir of the author, with notes on the pedigrees and military services of the Ross-Lewins, Lewins, Donelans, Westroppe, and other families of the South and West of Ireland. The work is demy 8 vo. cloth, 368 pp., and will be published at 7s. 6d.
