

Sheehy was charged with disorderly conduct and assaulting Constable Hawkshaw and Sergeant Murphy on Sunday night last.

Mr. J. S. Gaffney, solicitor, said the defendant was sincerely sorry for his conduct to which he had no excuse.

District Inspector O'Hara said the man caused a great deal of trouble in the street. People followed and groaned the police, and some stones were thrown.

Mr. Gaffney said that the defendant was out in South Africa, all through the war, and was wounded several times. He fought at Colenso and Spion Kop. He (Mr. Gaffney) had come to the conclusion that there must be something wrong with his brain, as a result of the campaign, as he had undergone great hardship. He seemed to have had some drink taken on this occasion, though he was not a drunkard.

Constable Hawkshaw repeated his evidence given on Monday; that at twenty past one he was called into the Salvation Army Hall by one of the officers, and asked to remove the prisoner, who was creating a disturbance. Prisoner assaulted him three times. With Constable Plover's assistance he got him out on the street. He gave the name of Ryan; refused to go quietly to the barrack. A large crowd collected, and commenced booing and shouting. The witness got a kick in the thigh from someone in the crowd, and a stone was thrown in the direction where the police were with the prisoner. Prisoner resisted violently on the way to the barrack. The crowd shouted to him not to go.

In cross-examination, the witness said he had not known the man before.

To Mr. O'Hara—Sheehy was not drunk on the occasion.

Sergeant Murphy said the defendant kicked himself, and took a "skelp" off his finger. He was very nearly creating a serious riot.

Mr. Gaffney—He got a little punishment himself.

Witness—Very little.

Head Constable Moore—He was treated very humanely.

Mr. Gaffney—There is no allegation at all against the police.

Sergeant Murphy said a window was broken in the barrack, the missile going through the billiard room.

Prisoner said he had some drink taken.

The chairman (Mr. Roche) said the prisoner's conduct was very bad. The bench has decided on fining him 40s. or a month in both cases, and ordered him to find bail for his future good behaviour himself in £10 and two sureties of £5 or another month's imprisonment.

Time was given to the defendant to get the bails, etc.

### KILRUSH HARBOUR.

Answering Mr. Patrick O'Brien in the House of Commons last night, Mr. Long said, the Master of the Rolls has, in the case of Vandaleur v. Glynn, judiciously decided that the foreshore in this creek belongs to the plaintiff, Colonel Vandaleur. An appeal against that decision is now pending, and until it has been decided the question of transference to the Kilrush Urban Council cannot be answered.
