We regret to have to record a very sad accident attended with fatal results which occurred at 7 Ballybunion, County Kerry, on Saturday. It would appear that Master Patrick I. Dundon, son of Mr. John Dundon, solicitor, Limerick, whose family have been staying for some weeks past at this watering place, fell off the cliff, and received such injuries as resulted in his death on Saturday night. The deceased, who was fifteen years of age, was, it appears, alone at the time of the accident, and was picked up some time later. He was a bright and promising boy, and great sympathy is expressed in Limerick and elsewhere with Mr. and Mrs. Dandon in their sorrow. The funeral took place this afternoon family burial place, Clounana, Co. Limerick.

A very serious accident occurred on Sunday evening at Blarney Castle. A lad named Thomas Murphy, residing at South Main street, Cork, who was on a visit to the grounds with his parents, entered the castle about five o'clock, and when coming down the steps, after being on the uppermost portion of the castle, he went to one of the windows to look out on the grounds. Whether he became dizzy or lost his footing is not known, but he fell from the window to the ground. Assistance was rendered, and the young fellow was removed to the Blarney Railway Terminus in a collapsed condition. The latter naturally became alarmed and on the way home reported the matter to Constable Sloan at Kilmurry, who arrested Liston, and on searching him at the station found a pistol and caps in his possession. He was brought before Mr Dowling, J.P., today, and discharged to be summoned.

WEDNESDAY.

The Most Rev. Dr. Fennelly, Archbishop of Cashel, visited Murroe on Tuesday, and opened a Bazaar in aid of the building fund of the new Parochial Church.

The Annual Show of the North Tipperary Agricultural Society was held on Tuesday, at There was a large increase in the Nenagh. Driving and jumping took place in the afternoon.

Lord Grenfell Commanding the Forces in Ireland, in a statement issued on Tuesday night, says that there is no truth whatever in the report published in the papers that two men of the East Lancashire Regiment were shot during rifle practice in Co. Wicklow. No such incident occurred.

After a somewhat prolonged iflness Mr. Williams Dobyns, Clerk of the Petty Sessions, Dingle died on Tuesday morning at his residence in Green street. Deceased had attained a comparatively ripe old age, and in the social sphere was a man who commanded the lasting friendship of not a few, and the esteem of all.

Two sudden deaths are reported from Sligo.

A labourer named Peter Giblin dropped dead on Monday at his dinner from heart failure. He leaves a wife and six children. A lady passenger on the 5.10 train from Tuam to Sligo on Tuesday, Miss M. M'Gowan, died on the journey. She was accompanied by her brother, returned from America, whom she went to meet at Queens-

A sad fatality occurred at Enniskillen on Tuesday evening by which a young fellow named Denis Kenny lost his life while bathing in an off-shoot of Lough Erne. Kenny, who was ahout 20 years of age, and employed in the Imperial Hotel as under boots, went out to bathe, and while the attention of his companion was otherwise engaged, suddenly disappeared. The body has not yet been found.

At the meeting of Arthur Guinness, Son, and Co., Ltd., on Tuesday, it was decided to place £140,000 to the reserve for capital expenditure and contingencies, £30,000 depreciation fund, to pay a final dividend of 8 per cent, and a bonus of 4 per cent on the Ordinary stock. This with the interim dividend is equal to the same

total dividend as last year, namely 20 per cent.
At the quarterly meeting of the North
Tipperary County Council, Mr. T. Corcoran
presiding, a letter was read from the Loca Government Board stating that as regards the appeal lodged by the Nenagh Urban Council againt the County Councils declaration to have no main roads a local inquiry had been held, and on the evidence the Local Government Board considered there was no ground for the appeal which had been dismissed.
