

Mr. Henry Ffennell's annual review of salmon fishing in the United Kingdom is always most interesting reading to everyone who takes a pleasure in the Waltonian Art. It would appear that the season in Ireland for 1904 was not a productive one. Locally we are aware already of that fact, but it is added that at the Corbally fishery, near Limerick, the season was one of the worst on record, only two salmon of 45lb. each one of 42lb., and one of 40lb. having been taken. At Castleconnell the spring angling season was one of the best of the last six years, whereas the peal fishing was an absolute failure.

The hearing concluded in Dublin on Saturday of the action for breach of promise of marriage, the plaintiff being Miss Frances Hanrahan, a barmaid, and the defendant Dr. Wm. A non-slipping pneumatic tyre, invented by Mr. Frederick Thorpe, Newmarket, Co. Cork, has attracted considerable attention lately, and has successfully undergone some severe tests.

On the ground that the preliminary certificate of good conduct accompanying the application had not been signed by the justices sitting in Petty Sessions, the Maryborough Workmen's Club were refused a certificate of registration under the new Clubs' Act.

The body of a labourer named Timothy Cronin was found lying on the roadside near Tuchigeela, Co. Cork, by the local postman on Sunday. Life seemed to have been extinct for some time. The police believe death was due to natural causes.

John Ahern, labourer, Kells, Drumcollogher, who is said to have had attained the century, died on the 8th inst. Those who knew him most intimately state that he had never seen a train, and had been only once in his market town, Charleville. He was a hard worker.

The funeral of the late Mrs. Julia Keane, Carey's Road, Limerick, whose remains, after death, were removed to St. Michael's Parish Church, took place from there to St. Lawrence's Cemetery, and was largely attended by the general public. Deceased, who was 55 years of age, was deeply regretted.

We regret to learn that on Saturday last the death took place, after a short illness, of Mr. E. M. Denny, of Chiddingstone Castle, Kent (head of the well-known firm of Messrs. H. Denny & Sons, of London, Waterford, Cork, and Limerick). Mr. Denny, who had reached a ripe old age, was stopping at Bexhill in Sussex, where his demise occurred. His funeral took place on Tuesday, and the entire works at all places above mentioned were closed as a mark of respect to his memory.

News of a shocking fatality comes from Ballybrea, near Enniskerry. A young man named James Judge was dislodging a stone of some seven or eight hundred weight in his adopted father's quarry. In order to see how the work was progressing he stooped down, placing his head close to the material, when it suddenly crashed from its position. The unfortunate man's skull was pinioned beneath the mass, his features being crushed almost beyond recognition. He was instantly killed. At an inquest held by Coroner Murray, J.P., a verdict of accidental death was returned.
