clear solution is obtained. It is then put aside to cool; and a precipitate settles. For a few days the solution may be cloudy, but eventually it becomes quite bright. It will be seen that this is a water varnish, and thus the films can be varnished wet or dry. They may require five minutes' immersion in the varnish to secure complete absorption of the varnish into the entire body of the gelatine layer. The films are then removed, drained, and hung up to dry. This does not take a very considerable time. OTHER USES.

Such a varnish can be used to give prints, even matt bromide prints (enlargements, &c.) a semigloss; also to make them waterproof; and it can be used to "fix" crayon work, or "black-and-white finish" on bromide enlargements. In all these cases it would seem to be best to spray the varnish on to the surface with a spray or "atomiser," For unworked prims, mere immersion, or several successive brushings with a camelhair brush (with intermediate drying), will be just as satisfactory.

THE DIFFICULTY. Our correspondent's difficulties arise first from the colour of the shellac. He has bought the ordinary orange shellac. This yields a brown stainy looking varnish. This can be disregarded for films; and, unless the paper is of a very porous character, it can be disregarded for paper too. It is best to try the effect of the varnish on a piece of the paper first. The ordinary orange shellac dissolves the most easily and yields the best "body." If less colour is desired, bleached lac must be used. Here comes in difficulty number (wo. "Simplissimuss" cannot succeed very well with it. First, let us say that only freshly prepared specimens of bleached lac are at all easily soluble. Old ones will be very refractory in dissolving, or may prove so. Secondly, there will always be less "body" with a bleached or white shellac varnish. Shaking must be continued at intervals for days, then decant and allow to settle, rise by immersing the print for at least five minutes. Dry, and if necessary give a second varnishing. Celluloid varnish will do even better, and yields no trace of stain. It can only be used on dry surfaces
