ALLEGED BURNING OF A MOUNTAIN.

At a special court held at Tipperary yesterday, before Mr. H. Turner, R.M., a farmer named Owen Egan, residing at Ardlomon, and a boy named James Quinn, aged 13 years, were charged with having on last Sunday maliciously set on fire the Slievenamuck Mountain, as a result of which several hundreds of acres of gorse, game cover, plantation, and heather were destroyed. Both prisoners were returned for trial at the next Quarter Sessions.

FUNERAL OF MR. JOHN O'TOOLE.

Yesterday the remains of the late Mr. John O'Toole, Thomondgate, were removed from St. Munchin's R.C. Church, where they had been deposited overnight, for interment in Mount St. Lawrence Cemetery. The deceased gentleman, who was a highly respected citizen, had reached the fine old age of 95 years. Up to twelve months ago he enjoyed comparatively good health, but recently the strain of his years told upon him, and on Wednesday evening he passed peacefully away.
