

... Ireland in the matter of its means of transit, and until such were done they could not hope for much progress. The Viceroyal Commission recently appointed to enquire into the working of the Irish railways, he hoped would throw much light on what he and others had to complain of, and do something to set it right. Mr. J. F. Power next spoke and said he quite agreed with Mr. Field as to the important part played by transit in connection with the Industrial Revival of Ireland. When Mr. Field spoke of transit he spoke of it, in relation to the railways as the traffic in inland waterways was of limited importance, and moreover they were controlled by the railways. The local rates in Ireland were much higher than in Continental countries, but what could be done to bring about a revolution. The last speaker had spoken of State control as a solution, but he did not agree with it, having regard to reasons, the most prominent of which was the repugnance of the Irish people to the hard and fast rule of Government. Mr. E. Gibson denounced the Irish railways as most detrimental to the trade of the country, and until they were purchased by the State there would be no fair play for the commerce of Ireland. Mr. George de Belle-Ball (Drogheda) said he was pleased to get an opportunity of speaking on the subject of railway policy. He instanced cases of preferential railway rates as applied to Drogheda, where they were to establish a line of coasting steamers to combat the monopoly of the railway corporations, especially the Great Northern Company. Mr. Field reverted to some of Mr. Power's observations as they related to foreign railways and their working. He referred to the injury done to the Irish live stock trade as it concerned the handling of stock, and said the only thing the carriers did was to extract the last penny out of the public to their detriment. Mr. E. Shackleton submitted a paper on the tanning industry. Some discussion followed, and the conference adjourned subsequent to a paper on agricultural machinery by Mr. W. F. Nichamara.

The death is announced of Signor Guiseppe, the well-known Italian dramatist. Two quick-firers and one other gun have been taken from a torpedo boat at Sevastopol. No trace of the weapons has been found. In recognition of his efficiency, Sergt. Lyons, Co. Kerry, has been presented with a medal by the Society for the Prevention of Cruelty to Animals.
