FUNERAL OF LIEUTENANT GEORGE, R.E.

The funeral of the late Lieutenant George,
R.E., who died at his residence, Wellington
Terrace, in this city, on Sunday evening, took
place this afternoon with full military honours,
the coffin containing the remains being borne on
a gun carriage of the Royal Field Artillery. A
firing party of 50 non-commissioned officers and
men preceded the bands of the 4th Battalion
Northumberland Fusiliers and after the coffin,
the pall-bearers being officers of the
Engineers and Artillery, the officers,
non-commissioned officers and men of the troops
in the garrison, and several civilian friends
walking in the funeral to King's Island, where
the interment took place in the military
cemetery.
