

ST. MARY'S KNITTING INDUSTRY.

APPLICATION FOR WORKERS.

At the meeting of the City Technical Committee last evening, Rev. A. Murphy presiding, The High Sheriff said he understood that Mrs. Quinn, proprietress of St. Mary's Knitting Industry, had not got the trained workers applied for through the Committee from Pery Square.

The Chairman said the answer from the school was that the workers were available. It was a question as to terms for themselves.

The High Sheriff said she applied, and did not get them, though the Committee required them to be sent.

The Chairman—You cannot drive these girls as if they were cattle.

The High Sheriff said the School at Pery Square had been subsidised by the Committee with a view to turning out lace and knitting workers. If it failed to supply the workers, what benefit was it to the Committee?

The Chairman—The workers are there and available, and it is a question for Mrs. Quinn to make arrangements with them.

Mr. Comerton said, in accordance with instruction received from the Committee, he sent a copy of the sister's letter to Mrs. Quinn and heard nothing from that lady since. In reply to the High Sheriff, Mr. Comerton said he told Mrs. Quinn that it would be better to make arrangements with the girls themselves.

The Chairman said Mrs. Quinn ought to go to the school, and he considered it nothing else but a pure piece of impertinence on the part of Mrs. Quinn to try to carry on a quarrel which failed to justify her action.

The High Sheriff held it was the duty of the mistress of those schools to send trained hands to anyone who wanted them—Mrs. Quinn or anybody else.

The Chairman said the whole thing was that Mrs. Quinn wanted to inflict humiliation on the nuns, but she would not do it.

The High Sheriff—That is not so.

After a long discussion about "the soreness that has arisen," the Chairman intimated that Mrs. Quinn had only to go to the school and arrange with the workers. She was taking up an unfair attitude, and he was sorry to see members of the Committee backing her.

Eventually, the High Sheriff said he would take it on himself to advise Mrs. Quinn to write to the Nuns for hands.

A GENUINE INJUSTICE. BAD FOR SHEEP FARMERS.

From 1st August to the middle of November next the best markets in Great Britain will be closed to Irish sheep in consequence of stringent and hampering regulations put in force by the Board of Agriculture. They have to be dipped a month previously, and as dipping facilities are not common among small sheep farmers a great hardship is likely to ensue, especially as the order also prevent lambs being sent, and lambs, as is well known, are often killed by premature dipping. The Agricultural Council to-day strongly protested against the new order, and called for its withdrawal or relaxation.

SAD DEATH AT GLIN.
