THE CUTTEEN SHOOTING.

EVIDENCE OF THE INJURED MAN.

(FROM OUR CORRESPONDENT).

On Saturday the magisterial investigation into the shooting of Michael Woulfe at Cutteen, Quin, on September 16, as already reported, was resumed at the County Court-house, Ennis, by Mr. A. Newton-Brady, R.M. The accused man, Patrick Meany, was brought up in custody on remand from Limerick.

Michael Woulfe said he had gone out to the farm to see the goods and Meany told him to clear out. Meany then drew a revolver and fired at him and hit him on the leg. Witness ran away and was followed by Meany, who again fired and hit him. He fell and when he was crawling up Meany was close to him with the revolver. Witness caught it and held it as a "murdering vagabond." He took the revolver from Meany, who, however, took it back again. Meany pressed him down, and when he got free he fired another shot which struck witness on the left side. Meany then fired another shot which struck witness on the back of the head. Meany then put witness's coat over his head as he was lying still on the ground. When witness came to he got up and made the best of his way home. He knew Meany for years and latterly had not been friendly with him.

NOTED ATHLETE DEAD.

SERGEANT ROOHE, KILMALLOCK.

Sergeant J. Roohe, No. 8 Company Royal Garrison Artillery, now stationed at Europa Gibraltar, died suddenly on the morning of the 11th October last. Regretted by all ranks. The deceased was a native of Kilmallock, County Limerick, and had a little over thirteen years' service, some of which was spent in Halifax (Nova Scotia) and Bermuda. He was a noted athlete, and had won many events, including high jump and short distance races in all these stations. Even so late as the end of September last he won a prize in the sergeant's race, he made the best long jump, but was disqualified for this event. The funeral took place at the Cemetery, North Point, Gibraltar, on the 12th October, 1900, and was attended by all available officers and men of No. 8 Company, R.G.A., sergeants and other non-commissioned officers and men from all the Royal Artillery Companies stationed at Gibraltar, the regiments and corps stationed in Gibraltar also sent representatives, a large number especially from the Royal Munster Fusiliers, Border Regiment, Duke of Cornwall's Light Infantry, Royal Army Medical Corps, Army Service Corps, Army Ordnance Corps and Royal Engineers.
