COLLIERY EXPLOSION

160 MEN ENTOMBED

MANY BODIES RECOVERED

An explosion occurred in the Wingate colliery Durham, late on Sunday night, and the loss of life is believed to be heavy. The disaster occurred in the Hutton seam, where sixty-eighty men were working. Thirty-five bodies have been recovered from this seam. In the main seam below one hundred and twenty were working. Every effort is being made to reach them.

GOOD NEWS.

ALL THE MEN RESCUED.

(BY TELEGRAPH TO-DAY.)

The Press Association's correspondent Wingate telegraphs—The men who were entombed in the Harvey seam at Wingate Colliery are being brought out this morning, and preparations are being made to bring to surface the bodies discovered yesterday in the low main seam.

A later message says—All the men in the Harvey seam have now been raised to the surface. There were 160 of them and all were well, having been fed last night plentifully. An exploratory party is now in the low main seam, and the bodies remaining there will be brought to surface next. The inquest will be opened tomorrow morning.

WORK RESUMED.

(BY TELEGRAPH TO-DAY.)

In accordance with the decision arrived at last night the women and girls employed at the Cartridge Factory, Edmonton, resumed work this morning. The question of wages was submitted to arbitration.

TOUCHING SCENE.
