MONEY GOES IN CAR DRIVING.

Whilst the maintenance expenses of ten technical instruction teachers in county Galway amounts only to £90 for the month ended July, the travelling expenses reached £120. This, the teachers says, is due to their having to live in the larger towns on account of the lack of suitable lodging in the country districts in which they teach. The committee on Saturday expressed strong disapproval of the amount of money spent in travelling, and ordered a letter to be sent to each of the teachers asking them to live in the centres in which they teach. The Secretary said that next year the committee would have to refuse absolutely to pay any expenses except for travelling from one centre to another.
