BIG BURLY BRUFFITE

And the Small Thin Man.

What the correspondent describes as a big burly man, Denis Hogarty by name, was charged at Bruff Police Court on Wednesday with assaulting John Connors, described as a "small thin old man." The latter had his head bandaged and alleged that the big man had cut his cranium with a big stick. Constable Mahony witnessed part of the assault, and took the old man to the doctor who dressed the wounds. "Most cruel and most cowardly" said Captain Fitzpatrick, R.M., who added the unwelcome intelligence that the big man must spend two months in the Limerick gaol, and be kept to hard labour, a sentence which stamps Captain Fitzpatrick as a "most worthy judge."

LICENSING ACT.

Bona Fide Traveller Question

At the City Petty Sessions yesterday, Thomas Hayes was charged by Constable McGrath with falsely representing himself to have been a bona fide traveller. Constable McGrath said he was on public house duty last Sunday night about twenty minutes to eleven, and visited the premises of Mr. Murnane. Defendant represented himself as a traveller from Patrickswell, whereas another Constable identified him as residing in the town. Defendant swore that he belonged to Patrickswell, and slept there the Saturday night previous. He worked in town.

A fine of 6d. was imposed.

Michael Power, publican, Queen street, was summoned for keeping his premises open for the sale of drink on Sunday last, and a boy named Naughton was summoned for being on the premises. It appeared from the evidence of Constable McGrath that Naughton was seen leaving the premises at 11 o'clock on Sunday morning. The police brought him back and found in his possession a bottle containing a pint of stout.

The case for the publican was that Naughton was a workman of Mr. Power's, and had been engaged that morning washing harness, etc., and on leaving, the publican gave him a pint of stout, as a gift, to take home to his father.

The case was dismissed.
