CLARE SUMMER ASSIZES.

OPENING OF THE COMMISSION.

Lord Chief Baron's Address.

(FROM OUR CORRESPONDENT.)

Ennis, Thursday.

His Lordship said that there were fourteen cases to go before them, and of these two were practically the same case, so that they would have but twelve separate cases to consider. Of these twelve there was only one which was really of much importance, although there was another about which he would have to make a few observations. He might tell them in the first instance that of those twelve cases the prisoners in two were lunatics, and the proceedings were taken for the purpose of putting them under due restraint. Of the other ten cases, by far the most important was the one which had been adjourned from the last Assizes, when from the injured man being unable to attend it was impossible that a bill could have been sent up to the Grand Jury. He meant the Lisdoonvarna shooting case.

His Lordship referred at some length to the law bearing on the matter, and also in relation to another case in which a person was charged with shooting at, and then with intent to disable. The evidence was that the accused fired into a house, and in
