## CO. LIMERICK WILL.

Dublin, Monday.

In the Probate Court to day, before Mr. Justice Andrews, in the case of Brazil v. Brazil.

Serjeant Moriarty with whom was Mr. Phelps, applied on behalf of William and George Linnan, two nephews of the deceased, that they be at liberty to intervene and plead in the action as defendants. Counsel said that Joseph Brazil who had been selected by the plaintiff, William Brazil, as the man he would like to fight as defendant, had come from America, and was living in the same house as the plaintiff at Ballylanders, Co. Limerick. This man, said counsel, was in collusion with the defendant.

Mr. Doyle, K.C., with whom was Mr. Roche, appeared for the plaintiff, who was a first cousin of the deceased, the defendant, Joseph, being a nephew. He desired to repudiate in the strongest possible manner the absolutely reckless and extraordinary statement made in the affidavit grounding this application as to collusion between the plaintiff and defendant. The action of the plaintiff was quite bona-fide, and as soon as he could get a next-of-kin in this country he instituted his action against him.

Serjeant Moriarty—He imported him for the purpose.

Mr. Doyle denied this. He said that the applicants stated they changed their names because somebody spelt it wrongly on a brass plate. (Laughter.)
