The monthly meeting of the Board of Management of the Glin District School was held on Tuesday, the Chairman, Mr. Patrick Hayes presiding. Also present—Limerick Union—Messrs J. P. Griffin, John Madden, M. Keane, J. P. Rabilly, Thomas Hayes, T. Lane. Kilmallock Union—Messrs P. Hayes, and Martin Mcagher. Croom Union—Messrs P. Hartigan, M.C.C., J. Costello, and T. Reidy, Listowel Union—Messrs Tim O'Sullivan, W. Collins, and John Carmedy. Newcastle West Union—Mr. John Barrett. Rathkeale Union—Messrs P. L. O'Sullivan, P. Lynch, M. Wall, and M. D. Conway.

Rev. C. M. M'Carthy, Mr John Conway, Clerk, and Rev. Bro. Shanahan, Master, were in attendance.

MARGARINE BILL.

The Clerk read portion of Mr. Kilbride's Bill (forwarded by that gentleman) for the prevention of the sale of margarine as butter.

A discussion arose over certain provisions in which the Chairman, Mr. Meagher, and others took part, and the opinion was expressed that the Bill of Mr. Kilbride would have the desired effect.

PORTER'S RATIONS.

Mr. Maurice D. Conway's notice of motion—"That the porter's rations be changed and put on level terms with the other porters in the contributory Unions of the Glin District School," was moved by him.

The Clerk submitted, as directed, a list of the salaries and rations given in the six contributory Unions.

After some discussion, it was agreed to, Mr. Maher dissenting, that the porter's rations be put on a level with the Croom porter.

RETURN ASKED FOR.

Mr. James Costello moved his notice of motion—"That the Master and Matron be directed to furnish the Board of Management with a list of boys and girls who have left the institution during two years from this date, and how they have acquitted themselves in the meantime, and that in future any boy or girl will not leave school without the sanction of the Board of Management."

Mr. Costello spoke as to the necessity of his motion being carried, and a discussion ensued, in which Messrs Lane, Collins, Maher, Reidy, and the Chairman took part, and during which it transpired that any child can take his or her discharge on reaching its eighteenth year and that a register of the children who have left is also kept in the Glin Institution.

Mr. Collins moved as an amendment that the latter portion of the notice of motion be struck out, viz: "That in future any boy or girl will not leave the School without the sanction of the Board of Management." He said it was their duty to look after them. They did not want to put any restrictions, only to get the names and addresses of the children.

On a poll the following voted for Mr. Costello's motion—Messrs. J. Costello, T. Reidy, the Chairman, J. P. Griffin, T. Hayes, T. Lane, O'Sullivan (2), Carmedy, Wall, Lynch, and Conway—12.

For Mr. Collins' amendment—Messrs. M. Maher, M. Collins, and J. Rabilly—3.

Messrs. Hartigan, Keane, and Madden, did not vote.

THE PLUMBER.

Mr. Joseph Griffin, in accordance with notice of motion, moved—"That the plumber be put on the same hours and wages as the city plumbers or the currency wages."

Mr. Madden moved as an amendment that the matter be left for the new Board.
