THE CORK STRIKE.

FRESH COMPLICATION.

Cork, Monday.

The correspondence published to-night between the Master Builders' Association, Cork, and the Builders' and Labourers' organisation discloses a critical situation, and should the matter in dispute not be settled by Wednesday there will probably be a universal lock-out in the building trades, and an augmentation of unemployed by nearly a thousand men. It seems that the builders' labourers refused to cart or work material which had been carted from the Packet Company and the Great Southern and Western Railway by men-society men, and were dismissed. This occurred in several places where building was in progress. To the masters' demands for information as to whether the action of the men was authorised by their society a reply was received declining to give information until the matter had been laid before the Executive of the United Trades' Council. To this the masters have sent an ultimatum demanding a definite reply by Wednesday morning, and describing the attitude of the men's society as most unsatisfactory.

THE ROCHE-O'BRIEN SUIT.

The Costs Incurred in the Case.

Yesterday, in the King's Bench Division, before Mr. Justice Madden and Mr. Justice Kenny, in the case of Roche v O'Brien, the Cork slander case, recently heard before Mr. Justice Kenny and a special jury, which resulted in a verdict for the plaintiff for £5 damages,

The Solicitor General, with whom was Mr. Cecil Atkinson (instructed by Messrs O'Connell and Dudley), applied on behalf of the plaintiff, the Hon. Alexis Roche, of Assolsa Castle, Co. Cork, for an order directing the Taxing Officer, Mr. Matthews, to reconsider and review the taxation of the bill of costs furnished by the plaintiff in the action, amounting to £928. It appeared that the sum had been reduced on taxation by about £300, mainly with respect to counsel's fees and witnesses expenses. The action had been brought against Sir Timothy O'Brien, Bart., of Lohort Castle, Co. Cork, to recover damages for alleged slander, and had been partly heard at the Cork Assizes before the venue was changed to Dublin.

A similar cross-application was made on behalf of the defendant, for whom Serjeant Moriarty and Mr. George M'Swinye (instructed by Messrs Wynne and Wynne) appeared.

The arguments having concluded, The Court affirmed the decision of the taxing officer, being of opinion that the matters in question were within his discretion, and refused both applications.
