It is for the Prime Minister to say when they will make that appeal to to the country which, in the opinion of nearly everyone, cannot long be deferred.

THE SITUATION IN SPAIN.

The "Matin's" correspondent at Madrid says The opposition parties in Spain are preparing to undertake an energetic campaign against the Republicans, Radicals, and Government. Liberals demand an immediate meeting of the Cortes. The decision of Senor Moret, Liberal Leader, as to the attitude to be taken by his party is impatiently awaited. Senor Moret arrived in Madrid on Friday. The Democrats are also in favour of the immediate assembling of Parliament. The whole opposition will probably form a powerful bloc, with the object of obtaining the restoration of constitutional guarantees and the re-opening of the Cortes. In reference to the internal situation the "Heraldo" states that Senor Moret is inclined to demand of the Gevernment that it shall accept its responsibilities as regards the exceptional regime under which Spain is living.

BALLYBUNION FATALITY.

On Sunday morning a farmer named Cornelius Corbett, of Newcastle West, aged about 70 years, was choked whilst partaking of his breakfast. He had been in delicate health, and accompanied by two daughters had come to Ballybunion recently. About 10,30 on Sunday morning he was at breakfast with his family and whilst eating some meat he was seen to struggle and make frantic efforts, evidently gasping for breath. It was found that a large piece of beef had got firmly fixed far down in his windpipe. The daughters endeavoured to render assistance, and meantime Sergeant Keenan arrived on the scene and did his best to extract the obstacls. Dr. Ferris was at once summoned and he did all that was in his power, but in ten minutes from the accident life was extinct. The sad occurrence has occasioned much regret.
