## KING LEOPOLD'S FUNERAL.

### Duke of Connaught

#### Represents King Edward.

The Duke of Connaught, who represents King Edward at the funeral of King Leopold left Charing Cross this morning for Brussels. Princess Patricia, who is visiting Sweden, accompanied her father so far as Calais.

## SKIRMISH IN FRENCH SOUDAN.

Celomb Beccar, Monday.

Captain Cancel, commanding the Camel Corps in French Soudan, while reconnoitering on December 9, encountered 300 horsemen proceeding to join the hostile Marabout. A fight ensued, the horsemen leaving 11 dead. The hostile Marabout on November 30 attacked a force of Soudanese troops, who resisted heroically, and suffered great loss.

## TRADE FUNDS AND PAYMENT OF M.P'S.

### House of Lords' Decision.

Judgment in the appeal of the Amalgamated Society of Railway Workers v. Osborne, which raised the question of the legality of Trades Unions making levies or using their funds for paying Labour Members of Parliament, was given to-day by the House of Lords, which dismissed the appeal with costs, deciding that such payments were illegal. Lords Halsbury and Maeraughton held there was nothing in the Trades Unions Act to uphold the power claimed of taxing members beyond the purposes for
