The following letter was read from the Loca Government Board :

Sir-I am directed by the Local Government Board for Ireland to acknowledge the receipt of the resolution of the Board of Guardians of Limerick Union of the 16th ultimo, relative to the acceptance of the record of age in the Union books as evidence of age of those claimants to old age pensions who are in receipt of poor law relief; and in reference thereto, I am to state for the information of the Guardians that the Board cannot lay it down as a rule that the entries in the Union registers are in all cases sufficient evidence of age; and in cases coming before them on appeal the Board must consider all evidence submitted to them either by the claimant or the pension officer. The Local Government Board would be disposed to consider that, as a general rule, the age recorded in the Census Returns of 1841 and 1851 would be more reliable than that by the claimant when applying for relief.

KILKEE WATERWORKS AND SEWERAGE.

(FROM OUR CORRESPONDENT.)

At the fortnightly meeting of the Kilrush Rural District Council on Saturday, Mr. W. C.

Doherty, J.P., occupied the chair.
Mr. Thomas R. Griffin, M. Inst. C. E., wrote that in consequence of the unfavourable weather he had to discontinue the work at the waterworks reser-A small amount of pitching would now be more economically and better done in spring, when the earthwork would be trimmed up and grass seeds sown. It was important that the trespass of cattle should be prevented during the winter months. He understood that the Kilkee Town Commissioners were prepared to arrange with the Council to procure a hose for the town, in which case he would be able to test the numerous hydrants. If it was not got it would be necessary to procure a stand-pipe and guage in order to test the pressure and insure that no leakages were taking place.

The Chairman said as regards the hose, he was Chairman of the Town Commissioners of Kilkee, but he could not speak for the entire body. He therefore asked them to defer the matter until the Board met and came to some conclusion in the

matter. eond

This was agreed to.

Referring to the recent decision of the Council that the existing sewerage be repaired at a cost not exceeding £1,000, the Local Government Board wrote reminding the Council that the evidence given at two sworn inquiries showed that the sewerage of Kilkee was in a most unsatis-factory state. This inclusion was corroborated by the Medical Officer of Health in his September report. The repair of the existing system new proposed would not be an adequate remedy, and the proper course was indicated in a letter dated the 10th ult. They directed that the necessary instructions therein contained may be given to the Council's Engineer without further delay.

An extract from a resolution adopted by the Town Commissioners was also forwarded by the Local Government Board, in which they were asked to take proceedings by mandamus for the enforcement of the Default Order, and this course would have to be considered if effective measures for dealing with the matter were postponed.
