The report of the Society's auditor, Mr. W. O'B. Hishor, was before the meeting. The members were gratified to find that the profits of 1910 expeeded those for any previous year. animated discussion took place as to the allocation of the profits. For some years past a dividend of 20 per cent. has been paid to the shareholders, but recently some disapproval of such a large dividend was manifested on the ground that it would be more in keeping with the purposes of the Society if a proportion of the profits were to be distributed amongst the suppliers. Some members maintained that as the shareholders asked money in starting the enterprise they were entitled to all profits. On the other hand it was contended that the shareholders should be satisfied with a 5 per cent, and the balance given to the suppliers as a bonus. Eventually the meeting adjourned for a week to give members ample time to consider this question and on reassembling the discussion was resumed. The following resolution was unanimously adopted. Proposed by Mr. J. Ambrose, and seconded by Mr. J. M. O'Grady—"That 5 per cent be paid to shareholders and one shilling per share he paid to those shareholders who are guarantors. Two and a half per cent, (6d in the £) to be paid to suppliers who are shareholders, and one and a quarter (3d in the £) to suppliers who are not shareholders.

A vote of thanks to the rev. chairman, who on returning thanks, observed that the staff of the Society deserve credit for their care and attention in its continued growing prosperity. - Com.

# INQUEST AT BARRINGTON'S HOSPITAL

adopted, after which the meeting adjourned.

Yesterday, Mr. J. F. Barry, J.P (City Coroner), and a jury, held an inquest at Barrington's Hospital, respecting the death of Richard Joyce, a small boy, who died in that institution as the result of injuries accidentally sustained on the evening of the 23rd ultimo.

Head-Constable He ily conducted the case on behalf of the authorities, and Mr. H. OB. Moran, solicitor, appeared for Mr. Michael Collopy, who was concerned in the case.

Evidence was given.

Mr. Wm. B. Joyce, B.A., deposed that he was the father of the decessed, who was six and a half years old. Witness last saw him in good health on the morning of the 20rd January. On the evening of that day a messenger informed him that his little boy met with an accident. He called for Doctor Holmes at the Crescent, and when he arrived at Henry street the boy had just been put into the ambulance in which he was taken to Barrington's Hospital. He was in the hospital until his death on Thursday morning.

Patrick Murphy, George Hotel, said he remembered the evening of the occurrence. He was in Henry street about three o'clock, nearly, opposite Miss Shannon's publichouse, when he saw a pony and trap coming up the street at a great pace. Just before coming to Miss Shannon's, the pony and trap got into collisien with an ass cart, and then swerved into the footpath, went into the channel, and swerved on to the footpath again. It passed a woman and child, and while in the channel course the pony swerved into the footpath again and knocked down the little boy. The pony and trap travelled for a few feet and then turned upside down. The boy got up and ran to his little sister. He was crying when witness took him up, and bleeding from the head. Witness took him into Miss Shannon's house, and left him there while he went over to McMahon's cooperage and telephoned for the ambulance. Witness put the child into the ambulance when it came to bring the little fellow. to Barrington's Hospital. He saw the boy running on the footpath to avoid the pony and trap tefore he was knocked down.

Several members of the jury complimented the witness on the intelligent and sympathetic manner in which he acted on the trying occasion.

The Coroner said nothing could well be better, and the witness deserved every praise for his kindly action in connexion with the sad occurrence.

Mr. Moran asked to be allowed to examine Mr. Michael Collopy, the owner of the pony and trap, as to what took place.

Mr. Barry said there was no occasion for Mr. Collopy's evidence at the inquiry, as all the jury had to do was simply to ascertain if the injuries inflicted on the occasion were the cause of

Mary Kate Franklin stated that on the evening of the occurrence Michael Collopy called into the shop in Henry street. There was apony and trap outside the door. A short time after there was a noise, and going to the door, witness saw a pony and trap running up Henry street.

Sergeant Heffernen said he arrived at the place shortly after the occurrence took place. Collopy was holding the pony by the head. Collopy said he was in Franklin's shop, and while he was there the pony ran away from the dor.

Dr. John Holmes stated he saw the child after the accident. The little boy was suffering from an extensive scalp wound at the right side of the head, and a fracture of the underlying front bone. Witness put the lad under chloroform, and attended him daily at the hospital until his death y esterniay.

The jury returned a verdict in accordance with the medical testimony.

#### The Funeral.

The funeral of Richard Joyce, the little son of Mr. and Mrs. W. B. Joyce, and who died at Barrington's Hospital as the result of injuries received through being accidentally knocked down by a pony trap, took place last evening for Mount St. Lawrence Cemetery.

The chief mourners were the three little brothers of the deceased :- Masters Garry, Frank, and Willy Joyce, and Mesers. B. Hanrahan, and C Hanrahan, relatives.

The clergy present were-Rev. J. O'Connor. Adm., St. Michael's ; Rev. Fr. Devane, C.C., do ; Rev. Fr. McNamara, C.S.S.R.; and Rev. Fr. Collins, C.S.S.R.

There was a large number of citizens at the funeral to show their sympathy with Mr. and Mrs Jovee in the trial they have sustained by the accidental death of a very winning lad.
