#### IMMENSE STRIKE

### Of Singer and Co's Employees.

The Press Association's Glasgow correspondent telegraphs—The ten thousand workers employed by Singer and Co., sewing machine manufacturers, at Kilbowie, near Glasgow, in support of six diamissed girls, turned up at the works to-day, but as no settlement was possible they returned to Glasgow. It is very probable that the manager will receive a deputation of the workers in the course of the day. Three hundred more employes joined the strikers this morning.

Thousands of strikers either congregate near the works or parade the streets in groups. It is understood no negotiations with a view to a settlement can be opened up until the return of the President and Managing Director to-morrow evening.

# Lord Justice Cherry's Criticism.

At Belfast Assizes to-day, John Jenkins pleaded guilty to having done grievous bodily harm to John Watson by throwing an explosive in front of the Independent Orange Hall during the Parliamentary election celebration. **Probation** charging the prisoner under the Offenders Act, Lord Justice Cherry said that it was unfortunate at the present time people in almost every political party should begin openly advocating violence as the method of obtaining They had titled ladies writing political changes. to the Times endeavouring to show violence was the only means by which political improvement, as they considered it, would be obtained. It was very deplorable, and it was not to be wondered at, that head-strong youths should transfer those principles into practice.


