Charges of Conspiracy.

Mr. and Mrs. Pethick Lawrence, Mrs. Pankhurst, and Mrs. Tuke, suffragette leiders, were, at Bow street, London, yesterday afternoon, remanded on charges of conspiracy and procuring persons to commit malicious damage to property. Mr. Bodkin, for the Public Prosecutor, said the case had reference not only to Friday's events, but to the condition of things London had experienced since Nevember. He would only give formal evidence that day, as many documents were still to be gone through, and Miss Pankhurst was not In the present case the prisoners in custody. were alleged to have connselled others to commit offences, and by speechez and violent, lawless writings sticred up the excitable rank and file of the women's organisation.

The prisoners were remanded for a week, bail

being refused.
Up to a late hour last night, the warrant for the arrest of Miss Christabel Pankhurst had not been executed.
