## BELFAST DISTURBANCES.

### Closing Notice by Messrs Harland and Wolff.

Messrs Harland & Wolff, Belfast, this afternoon issued a statement that owing to the impossibility of properly carrying on work in their shipyards through assaults and intimidation of workmen, several departments have already closed down. Extremists have molested specially skilled men responsible for working the power plant, and these have ceased work. As they cannot be replaced, the firm will have to gradually close the whole establishment.

## FUNERAL OF MR. ELDRED C. HOLLIDAY.

The remains of the late Mr. Eldred C. Holliday, whose death took place suddenly on Wednesday, were interred yesterday morning in the family burial place at St. Mary's Cathedral. At 11 o'clock, the coffin was removed from Olivette, Ennis Road, and along the line of route the blinds in the several business establishments were drawn. The funeral was of very large dimensions, and testified to the esteem and respect in which the deceased was held by his fellow-citizens of every class. On arriving at St. Mary's, the coffin was borne into the Cathedral where the Service was conducted by the Rev. Canon Langbridge, Rector St. John's, and the Rev. Precentor Adderley. At the close of the Service, which was partly choral, the remains were laid to rest at the southern side of the Cathedral, the Committal sentences being read by the Precentor.
